## **Introductory provisions**

- 1. Skal Biocontrole is the independent organization that monitors the entire organic chain in the Netherlands. Skal is dedicated to proving the reliability of organic products for consumers through monitoring, registration, and certification.
- 2. As of 1 January 2022, this includes the following four target groups:
  - Sales to consumers (B2C);
    - B2C includes: online stores that sell directly to consumers and/or businesses, head offices of all companies affiliated to it in any way, such as affiliated shops and/or other retail outlets, and/or franchise companies and/or distribution centres, independent shops and market stalls:
  - Low-risk companies;
  - Normal-risk companies;
  - High-risk companies.

If the target group is NOT B2C, an operator is classified in the year of notification in the Normal-risk companies target group.

The overview on the following page gives the amounts and rates applicable to each target group.

- 3. On the basis of the situation as of 1 January and on the basis of certain criteria, companies (with the exception of companies in the B2C target group) are classified as being at Low, Normal, or High-risk. This risk classification is further explained in the Regulations for Certification and Supervision (R11).
- 4. If the audit is discontinued because the inspector cannot properly perform the audit, the costs of the discontinued audit will be borne by the operator. This applies to all types of audits. The audit is then carried out again at another time. The costs for this are also for the operator's account.
- 5. Please refer to the Skal Contribution Regulations, R15, for the general terms and conditions for financial obligations.
- 6. Companies that prepare food products or animal feed including the manufacturing, importing, trading and storage thereof.
- 7. All amounts are exclusive of VAT.
- 8. This rate sheet replaces all previous versions of the Skal Rate Sheet.
- 9. The amount of the established fees are presented to and approved by the Minister of Agriculture, Nature and Food Quality.
- 10. Adjustments to these regulations take effect following approval by the Minister of Agriculture, Nature and Food Quality. Skal may adjust its fees annually.

## 1 Registration fee and the initial audit

An operator pays a one-off fee upon registration;

- 1. the registration fee (see p. 1.1);
- 2. the costs for the initial audit consist of the audit time (see p. 1.2);
- 3. any applicable surcharge (see p. 1.3 and p. 6);
- 4. In addition, the operator annually pays, therefore also in the first year, in proportion to the annual fee (see p. 2) and in proportion to the supervision fee (see p. 4) and the full certification fee (see p. 3).

### 1.1 Registration fee

This is a payment for the evaluation of the registration and the creation of a digital dossier.

#### 1.2 Initial audit

The costs for the initial audit consist of the audit time. The audit costs are calculated based on time spent.

### 1.3 Surcharges to the registration fee and initial audit

#### 2 Annual fee

The annual fee applies per calendar year. Operators that are registered for a part of the year pay a registration fee proportionate to their registration period. Skal applies different charges for the various target groups. These definitions are laid down in Article 3 of the Skal Regulations for Certification and Supervision (R11).

#### Category: 'regular annual fee'

This fee applies to the operators that do not fall under the 'small organic company' category or 'manure agent'.

#### 'Small organic company' category

Small organic companies are operators that comply with the following conditions:

- the organic turnover for the previous financial year (2022) was demonstrably €50,000.00 or less; and:
- the company is fully organic, i.e. there are no activities involving conventional products.

Small organic companies must submit an annual statement to this effect within the set deadline.

The following annual subscription fees are applicable to small organic companies:

Agricultural businesses	€113.00

#### 'Manure agent' category

Operators that meet the requirements of the 'manure agent' category (storage and processing of organic manure). Initial audits are not carried out at these operators, only a periodic audit. These operators cannot apply for an urgent procedure.

The following annual subscription fees are applicable to these operators:

#### 3 Certification fee

The certification fee applies per year. The certification fee covers the indirect costs for certification during the validity of the certificate. Operators who sign up during the year pay the full certification fee. In the event of withdrawal, there will be no refund for the remaining period of the calendar year. The subscriptions are as follows for the various target groups:

Online stores that are only registered are exempt from paying the certification fee.

## 4 Supervision fee

The supervision fee applies per calendar year. The supervision fee covers the costs incurred for Skal's supervision of affiliated operators. Operators that are registered for a part of the year pay a registration fee proportionate to their registration period.

#### 5 Periodic audit

The annual audit costs consist of a charge for the duration of the audit. The audit duration is calculated based on the time spent, with a minimum of one hour. This means that the annual audit cost will always amount to at least 111.00. If the audit lasts longer than one hour, Skal will charge the extra time at 111.00 per hour.

Skal calculates the annual audit costs for each location. The guiding principle is that each location undergoes one audit per year.

If the inspection has to be cancelled within one hour, because the inspector cannot perform the audit, only  $\[ \le \] 221.00$  will be charged. That rate matches the rate for an audit cancelled by the operator within fourteen working days of the planned audit date (see p. 6 Additional fees). If the inspector has to cancel an inspection after an hour has passed because the audit cannot be performed,  $\[ \le \] 221.00$  fee plus the audit time will be charged.

In line with the organic regulations, Skal can assign a low-risk or high-risk target group to certain companies. The operators in the Low-risk target group are audited once a year every two years and

pay these audit fees only in the year of the audit. For operators in the High-risk target group, there is an additional mandatory paid audit.

The risk classification of the operators is further explained in the Regulations for Certification and Supervision (R11), which can be found on the Skal website.
